SINCE NCPG LICENSED THE 1-800-GAMBLER NUMBER IN 2022, THE NATIONAL PROBLEM GAMBLING HELPLINE HAS EXPERIENCED RAPID GROWTH IN AWARENESS, ACCESS, AND EFFECTIVENESS, INCLUDING A 34% INCREASE IN MONTHLY CALL TRAFFIC.THE NCPG HELPLINE IS THE ONLY SUCH '911' SERVICE IN THE U.S. FOR PEOPLE DEALING WITH GAMBLING PROBLEMS (INCLUDING FAMILY AND LOVED ONES) AND IS THE ONLY ACCESS TO HELP IN MANY STATES. WE ALSO CREATED A PUBLICLY-AVAILABLE NATIONAL HELPLINE ANALYTICS DASHBOARD PROVIDING INFORMATION ON INCOMING TRAFFIC TO THE HELPLINE.
